2. Late Entries

Late entry fees will be charged as follows:-

To admit a new candidate or to allow the addition of a subject/module to a candidate's new entry between the closing date and the late entry date for each session as appropriate, a fee equal to double the normal entry fee for that subject/module will be charged, rising to three times the published fee closer to the examination session

3. Transfer of Entry

A transfer fee of £75.00 per candidate will be charged for the transfer of a candidate's entry from one international examination centre to another. UK registered candidates who have to be overseas at exam time for reasons other than holiday can ask for transferral of centre. The entry remains a UK entry and the candidate must find a centre overseas which will act as a 'host'. Edexcel International can help with suggesting a suitable overseas centre but cannot guarantee that facilities will be made available. Candidates currently registered at an overseas centre wishing to take their examinations in the UK will have to withdraw from the International entry and register in the UK by contacting the Edexcel Operations by e-mail at the following link: www.edexcel.org.uk/ask Full details of transfer of entry requirements are available in the International Manual.

4. Certifying Statement of Results

A Certifying Statement of Results is an official copy of the final examination results held by Edexcel and will be issued instead of the current replacement certificates, letter of success, letters of confirmation, statement of performance/transcript. It is available either for the candidate or may be sent as an official document to bona fide educational institutions, professional bodies and prospective employers. A fee of £30.00 is payable for this service to cover all examination sessions taken within one type (i.e. all GCE = £30, all GCSE = £30, all GCE + all GCSEs = £60). Up to 5 statements of one examination type sent to a third party = £30. If there are 2 examination types the cost will be £60.

NB: The candidate may have only one certifying statement of each type.

Full details of Certifying Statement of Results requirements are available in the International Manual.

5. Mode 2 Examinations

Additional fees are payable by centres which enter candidates for Mode 2 examinations. These fees will be notified direct to the centres concerned.

6. Annual Registration Fee

A minimum annual invoice of £2500.00 will be charged for those centres which provide an annual fee income of less than £2500.00.

7. Ad Hoc Inspection Fees

Please note that all centres will be subject to periodic ad hoc inspections during the conduct of the examinations. These are to ensure that the examinations are being administered correctly. Every effort will be made to minimise expenditure but the cost of these inspections will be re-charged to the centre by the inspecting authority as part of quality assurance.

8. Fee Refunds

All fee refunds will be made by credit note direct to the centre. Centres should make their own arrangements to refund individual candidates. Edexcel International will not normally make individual refunds.
